Nebraska Wheat visits Capitol Hill

The Nebraska Wheat Growers Association and Nebraska Wheat Board participated in the Winter Wheat Conference for U.S. Wheat Associates and the National Association of Wheat Growers. The conference took grower representatives and staff to Washington, DC for four days.

During their time in DC, representatives participated in meetings and discussions with farmer leaders from 19 other states. Topics included trade policy, Farm Bill implementation, conservation, transportation challenges, white wheat, communication tactics, research and wheat quality.

NWB and NWGA leaders also took time to visit Capitol Hill and discuss agriculture and trade policy concerns affecting Nebraska wheat producers with all three congressmen and both senators. They also participated in the Nebraska Breakfast event, the Wheat 103 education reception, and hosted a Nebraska Wheat Reception for Nebraska congressional representatives and staff. A few NWGA and NWB members also assisted the National Association of Wheat Growers with visits to key ag committee representatives from other states, including: Congresswoman Cindy Axne, D-IA; Senator Joni Ernst, R-IA; and Senator John Boozman, R-AR.

During the Wheat 103 education reception hosted by the National Wheat Foundation, representatives from all parts of the grain chain, including research, transportation, milling, farm equipment, millers, bakers and grocery retailers were able to share the story of wheat with congressional leaders and staff members from multiple states. The National Association of Wheat Growers also presented their Wheat Leader of the Year Award, which was given to Nebraska's Senator Ben Sasse in recognition of his efforts on trade. All of Nebraska's wheat leaders were present for the giving of the award.

NWGA leadership will meet again with other state wheat leaders during the National Association of Wheat Growers' annual meeting held at Commodity Classic. 



District 6 represents the eastern half of Nebraska and includes the following counties: Keya Paha, Boyd, Knox, Cedar, Dixon, Dakota, Brown, Rock, Holt, Antelope, Pierce, Wayne, Thurston, Blaine, Loup, Garfield, Wheeler, Madison, Stanton, Cuming, Burt, Valley, Greeley, Boone, Platte, Colfax, Dodge, Washington, Sherman, Howard, Nance, Merrick, Polk, Butler, Saunders, Douglas, Sarpy, Hall, Hamilton, York, Seward, Lancaster, Cass, Adams, Clay, Fillmore, Saline, Otoe, Webster, Nuckolls, Thayer, Jefferson, Gage, Johnson, Nemaha, Pawnee and Richardson. NWGA Amended Resolutions

At the recent annual meeting, NWGA updated, amended or added the following resolutions. For a complete list of NWGA's resolutions, please contact the NWGA office.

I-A Nebraska Wheat Board

I-A-1: NWGA would strongly oppose any attempt to divert excise tax dollars collected on wheat for wheat promotion to the general fund or for any other purpose.

I-A-2: NWGA would strongly oppose any efforts to reduce the wheat excise tax, allow refunds, or eliminate the Nebraska Wheat Board.

I-A-7: NWGA directs officers to monitor possible commodity checkoff legislation and act in the best interest of the wheat producers of Nebraska.

I-B Political Affairs

I-B-4: NWGA is in favor of changing school base funding for the purpose of property tax relief, while ensuring school funding remains adequate for education of students.

III-A Federal Farm Policy

III-A-12: NWGA requests the ability to adjust/update reinstatement of base acres for expiring CRP contracts to reflect current farm practices.

III-A-15: NWGA supports moving FSA certification of fall planted crops back to June 15.

III-B Taxes

III-B-1: NWGA supports the elimination of all county, state and federal taxes on the value of the estate at time of death.

III-B-8: NWGA supports changing the current method of taxing real estate for local services, from the comparable sales method to a production income based method.

III-B-10: NWGA recognizes possible efforts to repeal local county government and school tax levy caps put in place by the legislature. NWGA supports a reduction in the level of all current tax levies and opposes the repeal of current caps.

III-B-12: NWGA opposes levies and taxes on agricultural inputs and acres to generate dollars to pay for groundwater depletion issues.

III-C Crop Insurance

III-C-3: NWGA recommends that on final claim adjusting, the crop appraisal would be 0 if the cost of harvest was equal to or less than the state of Nebraska average custom harvest rate, even if the crop is harvested.

III-D Transportation

III-D-4: NWGA is firmly opposed to federal legislation that requires 75% of all PL 480 sales and food aide grants be shipped on U. S. ships with freight subsidies paid from the USDA budget. Also, the NWGA supports the repeal of the Jones Act. U. S. freight rates are much higher than foreign ship rates. If U. S. ships need subsidies it should come from either the Department of Commerce or the Defense Department.

IV-C Energy and Environment

IV-C-8: The NWGA supports drilling for energy in the ANWAR region of Alaska and in any international waters.

IV-C-9: NWGA opposes any limitation of grain usage for ethanol and biofuels production.

V-A Research

V-A-6: NWGA encourages the NWB to continue to explore avenues to promote and develop market access of Hard White Wheat.

VI-A Domestic

VI-A-8: NWGA requests full disclosure of basis in the wheat market in the form of itemization on producers' settlement sheets.

SECRETARY PURDUE SELECTS THREE SENIOR LEADERS AT USDA

On January 28, 2019 U.S. Secretary of Agriculture, Sonny Perdue selected three highly-qualified individuals for senior leadership positions at the U.S. Department of Agriculture (USDA). Perdue named Dr. Mindy Brashears as Deputy Under Secretary for Food Safety, Naomi Earp as Deputy Assistant Secretary for Civil Rights, and Dr. Scott Hutchins as Deputy Under Secretary for Research, Education, and Economics. Perdue stated, "At USDA, we've been engaged in fulfilling our mission without all of our players on the field, so we want to get these strong, qualified leaders in the game". Brashears, Earp, and Hutchins will begin working at USDA on Tuesday, January 29, 2019.

USDA AWARDS AG TRADE Promotion Program Funding

On Thursday, January 31, 2019, U.S. Secretary of Agriculture Sonny Perdue announced that the U.S. Department of Agriculture (USDA) has awarded \$200 million to 57 organizations through the Agricultural Trade Promotion Program (ATP) to help U.S. farmers and ranchers identify and access new export markets. The ATP is one of three USDA programs created to mitigate the effects of unjustified trade retaliation against U.S. farmers and exporters. USDA's Foreign Agricultural Service (FAS) accepted ATP applications between September 4 and November 2 – totaling nearly \$600 million – from U.S. trade associations, cooperatives, and other industry-affiliated organizations. U.S. Wheat Associates is one of the funding recipients who will be receiving more than \$8.2 million.

TRADE MITIGATION FUNDS WILL BENEFIT EXPORT MARKET DEVELOPMENT FOR U.S. WHEAT GROWERS

(Washington, D.C.) – U.S. Wheat Associates (USW) and the National Association of Wheat Growers (NAWG) are pleased that U.S. wheat growers now have the opportunity to increase efforts to expand export market access with USDA's Jan. 31 announcement awarding 200 million to 57 organizations through the Agriculture Trade Promotion Program (ATP). USW was awarded 88.25 million, which will be distributed over the next three years.

Administered by USDA's Foreign Agricultural Service (FAS), the ATP is one of three USDA programs within the Trump Administration's trade mitigation package created to ease the effects of recent trade retaliation against U.S. farmers and exporters. The funds will support export market development programs led by U.S. trade associations, cooperatives and other industry-affiliated organizations.

"U.S. wheat growers are facing tough times right now with the impact of retaliatory tariffs putting a strain on the export market and threatening many decades worth of market development," said Chris Kolstad, USW Chairman and a wheat grower from Ledger, Mont. "We appreciate the recognition that farmers need help to manage this additional risk. This program is a positive step forward and our people are ready to get to work."

"With the United States exporting half of the wheat crop it grows, programs like the Agricultural Trade Promotion Program (ATP) are crucial for our farmers to remain competitive in the global market," stated NAWG President and Sentinel, OK wheat farmer Jimmie Musick. "We welcome today's news that our sister organization U.S. Wheat Associates was awarded significant funding for trade mitigation activities. This funding will provide some relief to the adverse impact wheat has felt since U.S. placed tariffs on Chinese goods, opening the door for retaliation. We hope to see these affected markets opened again quickly."

U.S. wheat growers have a long history of recognizing the value of export market development by supporting the successful public-private partnership between USW's state wheat commission members and FAS. Each year, growers contribute a portion of their wheat sales which qualifies USW to apply for matching funds through FAS programs like the Market Access Program (MAP) and the Foreign Market Development (FMD) program.

2019 National Wheat Yield Contest Officially Opens

The National Wheat Foundation (NWF) is pleased to announce that it is accepting grower enrollment for the 2019 National Wheat Yield Contest! The Contest is divided into two primary competition categories: winter wheat and spring wheat, and two subcategories: dryland and irrigated. The Foundation is accepting entries for Winter and Spring Wheat. The deadline for Winter Wheat entries is May 15th with an early registration deadline of April 1st. The Spring wheat entry deadline is August 1st, with an early registration deadline of June 15th.

"America's wheat farmers produce the highest quality wheat in the world which should be taken into account when determining criteria for this national contest," stated NWF Board President and Idaho wheat grower Wayne Hurst. "2019 will be the first year that we truly see how a quality component will impact the rankings of growers and influence results."

In order to be considered for a national or state award in the contest, growers must follow up each initial contest entry with a grain sample, which will be analyzed by an independent lab. To qualify, samples must meet a quality Grade of 1 or 2.

"The National Wheat Foundation would like to thank 12 our sponsors for helping to make the Contest available to all wheat growers across the United States," continued Hurst. "As we incorporate the new quality component into Contest, we will need help from our partners to educate wheat farmers on this standard."
